States' 4-H International Exchange Programs Present Ohio 4-H Team with Award



The Ohio 4-H volunteer team was recently recognized for their 25th consecutive year of 100% ontime placement of Summer Inbound delegates with host families, with an average of 110 host families each year. Ohio had 18 consecutive years of 100% on-time placement of Year-Long delegates, with an average of 11 host families annually. Including all programs, this represents over 3,100 on-time placements.

Sexting and Sextortion Webinar

The Federal Partners in Bullying Prevention are pleased to announce "Sexting and Sextortion: Keeping Kids Safe," the concluding webinar in a two-part series that began in October. On November 20, 2014 from 2-3pm EST, the U.S. Department of Justice's (DOJ) Office of Juvenile Justice and Delinquency Prevention will host this webinar in collaboration with the U.S. Departments of Justice, Education and Agriculture, the Federal Bureau of Investigation (FBI), and the Internet Crimes Against Children Task Force (ICAC).

This webinar will focus on sexting and sextortion. An ICAC Commander will define sexting and share information to help parents, teachers, counselors, coaches, and school resource officers understand the dangers involved. Presenters will also provide tools on how to help youth say "no" to sexting. The FBI will then discuss sextortion and the associated peril, laws related to sextortion, and resources available to those who work with youth.
