Time to Celebrate! - Ohio 4-H GEN Has Received Approval

Ohio 4-H Youth Development Program has finally received their own Federal Group Exemption Letter from the IRS – GEN 5925. It has been such a long time coming! With this group exemption, donors can be assured that their donations are going to a 501 (c) (3) organization.

We expect there to be a period of adjustment to parallel our data with the IRS. We are waiting for the IRS to complete the data transfer. Please continue to keep an updated county EIN list of 4-H clubs/affiliates. Counties will also want to make sure that the new template for constitutions has been adopted by all groups and that charter checklists, needed MOUs and financial reporting is up to date. Cleaning up the data will make the annual 990 reporting system much easier for our 4-H advisors and personnel.

Emergency Tax Exemption Letters

Upon request, "Emergency Tax Determination Letters" will be prepared for chartered 4-H clubs and duly authorized affiliated 4-H organizations under control of Cooperative Extension. "Determination letters" are prepared for clubs/affiliates that cannot accept funds for grants without some evidence of tax exempt status to share with a funder. These letters are solely for the purpose of documenting for a donor or grantor the status of the 4-H subsidiary so that a group is not prevented from receiving funds. No other use is authorized.

County 4-H Professionals should send a club/affiliate request to the State 4-H Office by e-mail to <u>jinks.2@osu.edu</u>.

The request must include:

- EIN#
- Club/Affiliated Group Name
- Contact person
- Address
- A statement from the 4-H Professional that the club is chartered, in good standing and under control of Cooperative Extension
- Reason for emergency letter request

Please allow approximately two weeks for responce to special requests. Letters will be sent directly to the contact person/address listed for the group.
