Tar Hollow 4-H Camps are overnight youth camps that are planned and conducted by trained teen volunteers (youth ages from 14-18 from Fairfield, Ross, Athens, and Pickaway counties). In order to prepare camp counselors for a cardiac or respiratory emergency that may take place at camp and provide them with future workforce skills, we offered 2.5 hours of hands-on CPR training to all of our camp counselors provided by two certified and trained medical personnel from the American Red Cross. The Ross-Hocking 4-H Camp Association provides onsite training that would allow for this additional skills training to take place and benefit all of our camp youth or any adult staff in the event of a true cardiac emergency.

On June 7, 2022, ninety-one teens attended Ross-Hocking Camp Association's Multi-County Counselor Camp Training. This all-day training took place at Tar Hollow Resident Camp in Laurelville, Ohio and included youth from Athens, Fairfield, Pickaway and Ross Counties. These teen leaders attend a minimum of 24 hours of training in order to serve as camp counselors within their county's 4-H program. This on-site camp training event allows teens the opportunity to participate in rotations specific to areas of camp, share ideas with other counties, and obtain American Red Cross CPR training. The CPR training was a new addition this year and made possible by a grant from the Ohio 4-H Foundation. These trained teen volunteers (youth ages from 14-18) are a key element to a successful summer at Tar Hollow 4-H Camp. Teens reported the Multi-County Counselor camp helped them "feel more prepared, learned CPR, emergency procedures, and feel more comfortable guiding their campers through camp experiences." Ninety-one volunteer teen camp counselors from 4 counties are better prepared to handle emergency medical situations while in the camp setting, in part, due to this training. Thank you to the Richard B. and Nancy E. Stahl Family Fund and Ohio 4-H Foundation Endowment Fund for making this training possible for our teens!

Q7. List your proposed objectives and goals. Describe how well the objectives and goals were achieved (i.e. what was the identified need, how did this grant-funded project meet it, and how do you know).

Goals:

1. Empower our volunteer teen camp counselors with lifelong skills that will protect our program participants as well as give back to other communities to which they are involved.
2. Lower the risk of a life-altering situation by preparing our volunteers to respond properly.

Objectives:

Provide in-person, hands-on CPR certification classes that can help our teens provide assistance when someone is faced with a cardiac or breathing emergency. One of the top concerns camp counselors voiced is not knowing what to do in an emergency even if it as simple as providing first aid (when to get a nurse, who should apply a bandage, or limit movement when injuries occur). This training would equip our camp counselors to make the best decision in the moment and protect our campers during 4-H camp.

These goals and objectives were achieved by having 91 teen camp counselors (youth ages 14-18) from Athens, Fairfield, Pickaway and Ross Counties participate in Multi-County Counselor camp and complete CPR Training. This training allowed teen volunteers to develop life-saving skills that can be used during the 4-H Camp season and in their daily lives.

Q8. Please share how you used your proposed evaluation plan and the results and impact of your project.

This program will be evaluated by each counselor's successful completion of the CPR training and receiving a certification card. All ninety-one teen volunteers successfully completed the mandated training and received a CPR card from the American Red Cross on June 7, 2022. This Certification is good for 2 years which will get teen volunteers through half of their 4-H camp counselor career.

Q9. Describe the target audience that was served. (i.e. how many individuals, ages, diversity, etc.)

Camp Counselors who participated in this training came from 4 different counties and had a wide variety of past camp participation (1-6 years of camp experience). Fifty teens were 1st year counselors, 17 teens had 2 years of counseling experience, and 24 teens had 3-5+ years of experience.

Tar Hollow 4-H Camp is located 10 minutes inside of Tar Hollow State Park which is approximately 25 minutes from the closest emergency care facility. The response time from local volunteer emergency services (at least 40-45 minutes total) in addition to this distance creates a cause for concern. Our teen volunteers work with over 1,075 youth ages 5-14 who attend summer camp at Tar Hollow Resident Camp. Our camper population is made up of 275 males and 800 females.

Q13. For continued programs, describe your future plans for sustaining the programming. Please share plans for fundraising, engaging volunteers, partnerships, etc. that will contribute to the sustainability of your program.

Some counties have 25-30 new camp counselors each year, so this program would help those new teen volunteers as they start their camp counseling career. This training will continue to serve 4-H teens and communities in which they engage for years to come, and help keep Athens, Ross, Fairfield and Pickaway Counties safer.

This programming will be sustained after the 4-H Foundation grant ends by camp counselors participating in CPR renewal courses in order to keep up their certification. This renewal course would be added as a session for those camp counselors. The fee for counselor's camp could increase in order to cover this training and sustain this program.

The project was held during Tar Hollow's Multi-County Counselor Camp training on June 7, 2022.
