

# VIRTUAL BREEDING SKILLATHON RULES

## GENERAL INFORMATION

A Skillathon is an event to test knowledge of specific subject matter using the experiential learning model of exploring, reflecting, and applying that knowledge. Skillathons are created from materials directly or modified from Learning Laboratory Kits, information provided in the Ohio 4-H Animal Resource Books, and other resources, along with input from industry experts.

Each Skillathon is comprised of four educational and challenging stations. Certain species of Skillathons offer different age-appropriate stations, such as junior, intermediate, and senior. Youth move from station to station, attempting to perform the tasks they are given within the allotted time. A facilitator is present at each station to offer directions without helping the exhibitor perform the station tasks or offering answers.

## RULES

1. In-person virtual Skillathons are open to any Ohio 4-H member, age 8 and in the 3rd grade or age 9 and in any grade to age 18 as of January 1, 2025, and any Ohio FFA member **exhibiting a breeding animal of that species** at the Ohio State Fair. Therefore, 4-H and FFA members turning 19 on or before December 31, 2024, are too old to participate in the Skillathons.

2. Youth are required to be breeding exhibitors at the Ohio State Fair in the specific species Skillathon for which they register to participate. The virtual Skillathon is specifically available for Sheep, Swine, and Beef exhibitors as part of the Outstanding Breeding Exhibitor (OBE) awards. All other interested youth should participate in the **in-person** Skillathons (please see the **IN-PERSON SKILLATHON RULES**) for more information on that contest.

3. There are 10 age classes – 8/9-year-olds through 18-year-olds. A parent/guardian, or responsible adult, **MUST** verify the youth's age at the time of Skillathon registration. If it is determined at the completion of the Skillathon that an exhibitor was entered in the wrong age class, the exhibitor will be disqualified from the competition and not eligible for placings or awards. **Parents/guardians:** Verify with your county Extension professional your child's correct 4-H age, as this is the basis for age classification.

4. Virtual Skillathon participation **does not qualify a youth participant for outstanding market exhibitor awards** at the Ohio State Fair. This is a separate event, and you must compete in person at the Ohio State Fair to qualify for OME awards. Youth who participate in the Virtual Skillathons are still eligible to participate in the in-person Ohio State Fair Skillathons, even within the same species.

5. Once a youth begins a quiz on the Skillathon, they **CANNOT** leave or start over. If they leave, the youth forfeit any further participation in that respective species Skillathon.

6. Skillathon participants are not permitted to use study materials or electronic devices (including but not limited to cell phones or smart watches) during the Skillathon testing time.

7. Skillathons will be proctored on-site at the Ohio State Fair. Times available to participate in the Skillathon will be on a first-come basis during the time ranges listed below:

- July 21<sup>st</sup>, 3:00 – 5:00 pm- Beef Skillathon
- July 25<sup>th</sup>, 8:00 am – 1:00 pm- Swine Skillathon
- July 25<sup>th</sup>, 3:00 – 5:00 pm- Beef Skillathon
- July 26<sup>th</sup>, 8:00 – 11:00 am- Sheep Skillathon
- July 31<sup>st</sup>, 8:00 – 11:00 am- Sheep Skillathon

8. There will be 4 stations in each Skillathon that will make up 4 separate, timed modules. Each station will have a time limit (typically 5 minutes per station). The four station categories for each species will be posted around June 15 at [www.go.osu.edu/osfskillathons](http://www.go.osu.edu/osfskillathons) on the respective species' Skillathon page. Any specific rules for an individual species will be outlined on the testing site.

**Possible Skillathon Station Topics may include** Quality Assurance; Breed I.D.; Nutrition; Animal Identification; Genetics; Meat Cut I.D.; Selection & Evaluation; Systems – Reproductive, Digestive, Nervous, Vascular, Skeletal, etc.; Animal Welfare and Handling – Housing, Environment, Health Care, etc.; Breeding; Diseases and/or Parasites.

**9. DOCUMENTATION IS REQUIRED TO RECEIVE ACCOMMODATIONS FOR THE SKILLATHON.** Accommodations (e.g. timing, reading assistance, etc.) are available upon receiving formal documentation of needs. Facilitators will do their best to accommodate a youth member's specific needs as documented. To best accommodate youth, **bring a copy of a Winning 4-H Plan, IEP, or other appropriate and current documentation** related to the program (4-H or FFA) the youth is representing with the youth to the event. If your child requires any testing accommodations, please contact us in advance at [4hanimalscience@osu.edu](mailto:4hanimalscience@osu.edu) to help expedite assistance during the testing window.

10. Ties for overall Skillathon awards and age class placings will be broken by the following procedure:

- 1<sup>st</sup>: Skillathon Station No. 2 score;
- 2<sup>nd</sup>: Skillathon Station No. 3 score;
- 3<sup>rd</sup>: Skillathon Station No. 4 score;
- 4<sup>th</sup>: Within age group Skillathon Station No. 1;
- 5<sup>th</sup>: Total score of common Skillathon Stations;
- 6<sup>th</sup>: Scoring segments within stations (same order – Station 2, 3, 4, and 1); and
- 7<sup>th</sup>: An additional test may be administered.

11. Photographing or video recording of stations is strictly forbidden and may result in the disqualification of associated youth participants

12. For species with more than one session of Skillathon, youth are only permitted to take the Skillathon once.

13. There is **no record book** competition for the Breeding Skillathon.

14. Results will be posted for each age category, age division, and overall, after the breeding final drive is completed.

## AWARDS

Youth in each age class will receive 1st through 10th place ribbons sponsored by the **Ohio State Fair**.

Each age winner and the overall Skillathon champion or age-group champion will receive additional awards sponsored by:

- Sheep: Hartschuh Livestock
- Swine: Deloye Farms LLC
