Ohio Friend of 4-H Award Criteria

Description

This award recognizes an individual, family, business or corporation that supports the Ohio 4-H Program in a charitable manner at the county, state, or national level.

Nomination and Selection Criteria

Any individual, family, business or corporation is eligible to receive the award who:

- is a current supporter at the time application is made
- has not previously received the award (the award may be received by an individual, family, business or corporation only once)
- has given observable or measurable support and contributions to the 4-H Program.

Up to three recipients will be selected on a statewide basis and will be presented with their award at the Ohio 4-H Volunteer Recognition Luncheon.

Information to be included in application

- 1. In approximately 300 words or less each response, please address the following:
 - a. Describe the activities, support, and involvement that the nominee(s) has provided to the 4-H Program. Were these new or ongoing activities?
 - b. What are the impact(s) or outcome(s) this support has made to the 4-H Program and to the lives of 4-H members and/or volunteers?
 - c. Identify the committees, boards, and groups with which they have been involved.
- 2. Attach two letters of recommendation/support from two additional sources other than the nominator:
 - a. Current 4-H member or 4-H Alumni
 - b. Current or former 4-H volunteer
 - c. Community Leaders

Note: No additional pages of information, photos, and/or news clippings should be included.

Award and Presentation Details

An "Award Announcement Letter" listing the award recipients, will be sent to County Extension Offices in early February. Extension professionals can then personally notify award recipients.

Award recipients will receive personal invitations to the Ohio 4-H Volunteer Recognition Luncheon directly from the State 4-H Office in early February. Each award recipient will receive an award during the luncheon at the Ohio 4-H Conference.
